## Up to \$400 Tax Credit Could Be Yours !!

The Arizona State Tax Credit allows an Arizona taxpayer to contribute up to \$200 per individual or up to \$400 per joint tax return. The contribution is made to the school of your choice and may be used for extracurricular activities, character education programs, after school enrichment programs and field trips. To qualify for the tax credit, your contribution must be made by December 31st. Complete the form and mail with your check and/or money order to the address listed on this form.

## How Does This Work?

The State Department of Revenue has issued the following guidelines:

- Checks must be payable to the individual school of the taxpayer's choice
- The credit is for \$200 per individual tax return or \$400 for married couples filing jointly and is not applicable to businesses or corporations.
- The credit is against taxes owed.
- If individual does not have any state tax liability, a tax credit will not be available for the current tax year. However, it can be carried over for five years.
- It is not a requirement that the taxpayer have a child enrolled in school.
- If not designated by the contributor, the school will decide the program based on greatest need.
- Contributor will be sent a receipt from the District Office and notification will be sent to the Arizona Department of Revenue.
